

## **WE BUY BAKKIES ONLINE AUCTIONS - POPIA DECLARATION**

- "Personal Information" (PI) means a person's race, gender, sex, pregnancy, marital status, national or ethnic origin, colour, sexual orientation, age, physical or mental health, disability, religion, conscience, belief, culture, language and birth; information about the person's education or medical, financial, criminal or employment history; any identification number, symbol, email address, physical address, telephone number, location information, online identifier or other particular association with the individual; the individual's biometric data; the individual's personal opinions, views or preferences; correspondence sent by the individual which is implicitly or explicitly private or confidential in nature, or further correspondence which would reveal the content of the original correspondence; another person's views or opinions about the individual, whether the information is recorded electronically or otherwise.
- "POPIA" shall mean the Protection of Personal Information Act 4 of 2013 as changed from time to time.
- PEKAR HOLDINGS PTY LTD t/a WE BUY BAKKIES shall hereafter in this context be referred to as "We Buy Bakkies Online Auctions".
- The We Buy Bakkies Online Auctions website servers we host are protected by industry standard security protocols.
- We Buy Bakkies Online Auctions stores customer data in a digital administration system. This system is accessible only by authorised persons who use their own authentication credentials used to access this data. Authorised persons access to PI are further controlled through the use of user level security.
- Where the digital administration system database is backed up and stored off-site, relevant industry standard security protocols have been implemented to protect this data.
- We Buy Bakkies Online Auctions is required to come into contact with or have access to PI and other information that may be classified or deemed as private or confidential. Such PI may also be deemed or considered as private and confidential as it relates to any third party who may be directly or indirectly associated with this declaration. Further, it is acknowledged and agreed by We Buy Bakkies Online Auctions that we will have the necessary consent to share or disclose the PI and that the information may have value.
- We Buy Bakkies Online Auctions will at all times comply with POPIA's Regulations and Codes of Conduct and that we shall only collect, use, and process PI it comes into contact with pursuant to this declaration in a lawful manner, and only to the extent required to execute the services, or to provide the goods and to perform our respective obligations to our customers and partners.
- We Buy Bakkies Online Auctions has put in place, and at all times, shall maintain, appropriate physical, technological, and contractual security measures to ensure the protection and confidentiality of PI that it, or its employees, its service providers or other authorised individuals comes into contact with pursuant to this declaration.
- Unless so required by law, We Buy Bakkies Online Auctions agrees that it shall not disclose any PI as defined in POPIA to any third party without the prior written consent of our customers, and notwithstanding anything to the contrary contained herein, shall any party in no manner whatsoever transfer any PI out of the Republic of South Africa.
